Sub : Declaration of DDO in favour of 10 DIETs at 1. Berhampore (Murshidabad) 2. Gandhigram (Hooghly) 3. Kalanabagram (Burdwan) 4. Jagatballavpur (Howrah) 5. Cooch Behar 6. (Suri (Birbhum) 7. Jaynagar (S. 24 Pgs.) 8. Purulia, 9. Uttar Dinajpur, 10. Dakshin Dinajpur.

In continuation of this Deptt.'s earlier No. 692-SE(Pry)/4P-16/09 dt. 27-7-04, the governor is pleased to say that upgradation of 13 Govt. PTTIs and setting up 3 new Institutes as District Institutes of Education and Training (DIET) in the State of W.B. so far and necessary posts have already been created in terms of Deptt.'s No. 633-SE(P) dt. 12-7-04 and Finance Deptt. vide their U.O. No. ES-236-Gr'B' dt. 23-03-02 etc. Principal of DIET was declared as D.D.O. for the establishment of DIET with the concurrence of Fin.(Audit) Deptt. vide their Gr. 'T' U.O. No. 626 dt. 09-07-04. But so far only six Principals have been appointed in DIETs at Barajagulia (Nadia), Sovanagar, (Malda), Banipur (N. 24 Pgs.), Jhargram (Paschim Medinipore), Belakoba, (Jalpaiguri) Chhandar (Bankura) and they have been performing their duties as DDOs already. Hence Govt. has decided to order the Lecturer-in-Charge/Principal of the respective PTTIs to act as Principal of DIETs namely 1. Berhampore (Murshidabad) 2. Gandhigram (Hooghly), 3. Kalanabagram (Burdwan) 4. Jagatballavpur (Howrah), 5. Cooch Behar 6. Suri (Birbhum) 7. Jaynagar (S. 24 Pgs.), 8. Purulia 9. Uttar Dinajpur 10. Dakshin Dinajpur, until further orders for smooth establishment of 10 DIETs under order No. 245-SE(Pry) dt. 30-3-06. They will act as DDO of the respective DIET on the strength of this order issued with the concurrence of Fin. (Audit) Deptt. vide their Gr. 'T' U.O. No. 626 dt. 09-7-04.
