NOTIFICATION

The Governor is pleased to appoint 35(thirty five) Senior Lecturers and 25(twenty five) Lecturers to the different DIETS from amongst the existing eligible faculty members of Government and Govt. sponsored PTTIs in the State. As per guidelines contained in the S.E.Department's No.1264-SE(P)dated 24-12-2004 read with No.594-SE(Pry.)dated 8-6-2005 the members of the Selection Committee comprising of the Director, S.C.E.R.T., W.B. Joint Director of School Education(A), W.B. and D.D.S.E., W.B. have selected, 60(sixty)candidates (names and their places of posting are in the annexure) through an interview and recommended their appointments to different DIETS. They are being posted to places noted against each.

2. The posts of 35(thirty five) Senior Lecturers and 25(twenty five) Lecturers are created in the DIETs by abolishing equal number of posts of this Cadre in 13(thirteen) P.T.T.I.s upgraded to D.I.E.T.s with the concurrence of Finance Department vide their No.Group-B, U.O.No.ES-86 dated 13-7-2004 and the approval of the Cabinet in its meeting dated 5-10-2004.

3. The Senior Lecturer and Lecturers will get the benefit of protection of pay, counting of past services as admissible.

4. The interse Seniority of the Senior Lecturers joining these posts will remain unchanged (as in the gradation list of Lecturers of P.T.T.I.s maintained in the School Education Directorate) and will be placed immediately below the names of Senior Lecturers recruited through PSC, West Bengal. The Lecturers joining these posts will have their Seniority unaltered (as were in the gradation list of Lecturers of P.T.T.I.). They will be senior to those recruited through P.S.C., West Bengal hereafter.

5. The appointment is made in the interest of Public Service.
