

Whereas it has come to the notice of the Competent Authority that the buildings and infrastructures of various schools and institutions of the School Education Department, Govt of West Bengal are being allowed to the organisations / bodies to be used for purposes other than education, thereby compromising the principal goals and objectives of furthering the cause of education where for those buildings and infrastructures are meant;

Whereas the use of such buildings and infrastructures of such premises for purposes other than education is negatively impacting the pedagogical interests of the students studying in such schools and institutions;

Hence, it is hereby ordered to all concerned to refrain from doing the same without due permission from the Competent Authority in the School Education Department and/or unless otherwise permitted by the extant Govt rules/Acts. Henceforth, all the institutional and school authorities shall refer such cases of use of school infrastructures and premises for non-educational purposes to their superior authorities who in turn shall refer such cases to the School Education Department for further action.

The Order is issued in public interest with the permission from the Competent Authority and takes immediate effect.


