NOTIFICATION

Whereas the Kelomal Govt. PTTI (Purba Medinipur) has been functioning as primary teacher's training institute for a long period as sanctioned by the School Education Department, Govt. of West Bengal vide Memo no.86-SE(Pry)/4P-24/2003 dated 24.1.2005 read with concurrence of FD vide their U.O. no.3517 (Gr-P Service) dated 26.9.2008.

In consequent upon this Department's proposal to MHRD, GOI vide No.1060-SE(P)/4P- 24/03 dated 03.11.2004 read with the recommendation of the "Organising Committee" as constituted vide this Department's Memo no. 512-SE(pry)/4P-24/03 dated 04.06.2004, the "Kelomal Government Primary Teachers' Training Institute" is upgraded to function as " District Institute of Education & Training (DIET), Purba Medinipur" with Second Campus at Mandarmoni, Purba Medinipur. The existence of PTTI from this institute is, therefore, withdrawn and only DIET will function from this campus and new staff is to be appointed/ transferred as per G.O.29-SE(P) dated 12.1.2009.

It is further reiterated that the Principal/Officer-in-Charge of the "District Institute of Education & Training" (DIET) in the Purba Medinipur with Second Campus at Mandarmoni, Purba Medinipur from hence and hereafter will be the "Head(s) of respective Office" in respect of the said Institute(s) under sub-rule (16A) of Rule 5 of the WBSR, Part-I and in respect of all the officials/ staff (academic and administrative) serving in the said Institute under her/him under sub-rule (5) of Rule 4 of the WBSR Part-II as notified in 978-SE(Pry)/DIET-10/04 dated 31.08.2005.

It is further notified that the Principal/Officer-in-Charge of the DIET Purba Medinipur will function as DDO of the respective DIET.

Therefore, it is notified that Govt. PTTI at Kelomal is hereby upgraded as "District Institute of Education & Training (DIET), Purba Medinipur" with Second Campus at Mandarmoni, Purba Medinipur and the students of the D.El.Ed Course of the PTTI is to be regarded as students of "District Institute of Education & Training (DIET), Purba Medinipur"


